He also was learned the Smritis (code of conduct). He attained the age twenty year till ~~such~~ <sup>the</sup> time he completed his education. Subsequently, in order to live in the company of Sadhus and saints he ~~was~~ <sup>he</sup> undertook the pilgrimage of a number of holy places such as Rajagriha, Benares, Prayag etc. This was followed by six years training in the Buddhism in ~~regions~~ <sup>monasteries</sup> of Nepal and Tibet. I have been informed by Sh.Aldo that the Statutory Auditors of the World Foundation have advised that functions relating to the management of my "Intellectual Property" should not be handled by the Foundation but a separate legal entity. I am also advised that according to competent legal advisors, full protection will be available for my Intellectual Property rights if they are entrusted for management to a company formed and registered in Italy under the applicable statute. In this context I have decided that further action in this regard should be taken as follows:

1. N.I.P.C. should be wound up forthwith and my "Intellectual Property" rights should be restored to me.
2. A new Company named - "NIRMAL VIDYA - LAPURA CONOSCENZA" should be registered in Italy under the relevant Italian statute.
3. The share holders of this company will be:
  - (1) Myself, 50%,
  - (2) My daughter Mrs.Kalpna Srivastave, 25% and
  - (3) My daughter Mrs. Sadhana Varma, 25%.
4. I will entrust my Intellectual Property rights for the whole world except for INDIA to this new company.NITL, a company registered in India under my Chairmanship will continue to handle all my Intellectual Property rights for the whole of India.

In relation to the transfer of my Intellectual Property Rights to a judicial entity based in Italy, I have now received the legal opinion of the advisers of both NIPC and of the Shri Mataji Nirmala Devi Sahaja Yoga World Foundation. In the light of this advice I have reached the following decisions:

1. NIPC should be wound up forthwith,
2. my Intellectual Property Rights should be entrusted to the Shri Mataji Nirmala Devi Sahaja Yoga World Foundation,
3. the Shri Mataji Nirmala Devi Sahaja Yoga World Foundation will grant to the new company that I am establishing in Italy (Nirmala Vidya), the distribution rights to my Intellectual Property for the whole world, with the exception of India,
4. responsibility for the preservation and defence of my Intellectual Property Rights will rest with the Shri Mataji Nirmala Devi Sahaja Yoga World Foundation, and
5. the share holders of the new company in Italy (Nirmala Vidya) will be:


